Hello, Everyone,

NCRA Update:

There are also many sources for education to prep you for the CTR Exam on NCRA's website.

NCRA sent a newsletter in early July asking for letters of support from your facility to help establish a distinct detailed occupation code of "Medical Registrar" in the office of Management and Budget (OMB) Standard Occupational Classification (SOC). Send letters and/or questions to policystaff@ncra-usa.org. The final decision for this will be made in 2018.

September 19, 2014 is the application Deadline for the Fall 2014 CTR Exam. The last 2014 testing window is October 18-November 8.

CoC Update:

The CoC is seeking input from registrars, data users, physicians, and others to modernize the FORDS manual. This project started in April 2014, and input will be gathered through an electronic survey, which will be open through September 2014

Education Chair, Jan Stengel, RHIA, CTR

The last coding workshop for 2014 was held August 4 at the Indiana State Department of Health. The workshop concentrated on directly coded stage. This included AJCC as well as Summary Stage 2000. To reinforce the rules and importance of chapter rules taking priority over the general rules, exercises were completed highlighting the following sites: breast, prostate, bladder, lung, and endometrium. This workshop was videotaped. The Indiana State Cancer Registry (ISCR) is working on having this available on the ISDH Website. NPCR and the CoC require clinical and pathologic AJCC stage as applicable. Clinical and pathologic stage is not to be mixed unless staging rules allow. Be sure to read the chapter rules as they take precedence over the general rules. Summary Stage is required by NPCR. Using the electronic manual on the SEER Website is preferred. It is found at: <u>http://seer.cancer.gov/tools/ssm/</u>

Collaborative Stage Transition

The standard setters are finalizing plans for the transition from Collaborative Staging (CS) to directly assigned AJCC TNM stage and SEER Summary Stage (SS). The final revisions are to be submitted by December 1, 2014. NAACCR Standards Volume II will be released July 1, 2015 and the EDITS Metafile is to be released September 1, 2015. The requirement for directly assigned AJCC TNM stage will be effective for cases diagnosed January 1, 2016 and later. Education and training will be ongoing.

<u>2014- 2015</u>

CS will continue to be collected for 2014 and 2015 diagnoses and requires conversion to CS v 02.05. NPCR, SEER, CoC and other work groups are working through NAACCR to determine the preferred method of collection and transmittal of data currently collected in CS. The CoC requires both clinical and pathologic stage when applicable. In order to practice one's ability to read and understand how to stage directly from the manuals, it may be wise to directly code AJCC Stage as well as Summary Stage and see how one's results compare with the derived stage after completing the CS fields. As always, physicians staging is required. Stage should be completed when physician stage is not available.

<u>2015</u>

NPCR (IN State Registry) will require directly coded SS (in addition to CS) beginning with cases diagnosed January 1, 2015. Summary Stage categorizes how far cancer has spread from the point of origin combining clinical and pathologic documentation. SEER recommends that the updated Summary Stage Manual on their Web site be used, rather than the Summary Stage Manual - 2000. <u>2016</u>

NPCR (IN State Registry) will require directly coded SS; Clinical T, N, M for all cases; and Pathologic T, N, M for eligible cases. AJCC 7th edition will be used until 2017. CS coding will be

discontinued except for some variables, especially many of the Site Specific Factors (SSF's). The standard setters will clarify which additional variables and SSF's will be collected.

FORDS

The FORDS Revision project is underway. The CoC is in the process of revising the FORDS manual. September 2014 is the deadline for anyone to submit suggestions on fields and data items that one would like to see made clearer or ones where new codes would be helpful. As we abstract sometimes we see first-hand where some of the coding options could be more useful and or defined better. This is a chance to give ideas before they finalize the latest revision. Submit suggestions by going to the following link: http://www.facs.org/cancer/coc/fordsrevision.html There are options to change, add or delete an item. They ask for examples of scenarios to provide the rationale for the change. They also ask for your contact information in case they need clarification from you. The contact information will not be disseminated.

RQRS

The Rapid Quality Reporting System (RQRS) has replaced the CoC standard for "Timeliness." Cases should not be submitted to the State, however, until they are complete. Facilities that use RMCDS software should put the cases in suspense until they are complete. Cases in suspense can be reported to the RQRS, but are not included in State submissions. Those who use other software should contact the vendor for a method to prevent submission of incomplete cases to the State Registry.

Grade for 2014

The standard setters have collaborated to consolidate and clarify the coding rules for grade (NAACCR item #440, Grade, Differentiation or Cell Indicator) for cases diagnosed January 1, 2014 and forward. The "Instructions for Coding Grade for 2014+" can be found at the following link: <u>http://seer.cancer.gov/tools/grade/</u>. Please save a copy of these instructions as your reference for accurately coding grade for cases diagnosed 2014 and forward.

SEER Web-Based Education

SEER has a new education portal at the following URL: <u>https://educate.fhcrc.org</u> There are case scenarios that can be abstracted. The answers with rationale are then provided when finished. CE's are also available. This is a free education tool. This application is supported only by Firefox and Chrome browsers.

Education

AJCC and Collaborative Stage are in the process of developing short You-tube videos to answer a specific coding question in 5 minutes. This can be accessed via the CS Website as well as You Tube. The content will include rules, schemas, resources and SSF's.

The NCRA Website has presentations that go over T, N, and M staging as well as Summary Stage. One can obtain CE's for a fee. There are also many upcoming Webinars on stage and the transition to directly coded stage. Please see: <u>http://www.cancerregistryeducation.org/tnmss-resources</u>

The next CTR exam is scheduled for October 18 - Nov. 8, 2014. The application deadline was September 19. 2014.

The State did purchase next year's NAACCR Webinar series. I highly encourage all of you to participate, as you are able. 


The ISCR is collaborating with the Indiana Cancer Consortium Data Committee on the new 2015 Indiana Cancer Facts & Figures for publication.
