First, I would like to explain a little about how being on the board of directors works. As you know each position has a job to do (see descriptions on our website). But did you know that at the first meeting each position submits their goals for the year and the proposed budget needed to accomplish those goals? This allows the board to view, evaluate and monitor expenses though the year in an effort to keep costs down. Each position has a job to do to help achieve the purpose of ICRA – education.

The office of president is a three year commitment to ICRA; my final duty is to chair the nominations committee. We will be mailing out requests for the nomination of ICRA officers very soon. Yes, serving as an officer requires some time and some effort. We also recommend that you attend the fall conference and three additional board meetings. If you drive in excess of forty miles to attend the additional meetings you may request mileage reimbursement.

I remember the first time I was nominated to serve, I was thrilled, honored and scared all at the same time. Education Committee Chair, Janet Stengel, RHIA, CTR

The Education Committee has completed its second workshop for 2013. On May 6, a workshop highlighting the Hematopoietic Database and Coding Rules and the 2007 Multiple Primary/Histology Coding rules was held at the Indiana State Department of Health. Several cases were completed using both coding manuals as well as a breast case that required the use of Collaborative Stage. To accommodate those who are unable to attend workshops, the Indiana State Cancer Registry is looking into the possibility of taping and having the workshops available for viewing both real time and as a link on the State Department of Health Website. We tested this in May and are still working out the details of how to make this most effective. More details will follow.

Please set aside August 12, 2013 for our next coding workshop. The Hematopoietic Database will be reviewed again as well as other coding exercises. If others have suggestions for topics, please forward them to me.

There was a major announcement made at NCRA regarding timeliness. Standard 5.2 will be changed from a standard on abstracting timeliness to a new standard focused on Rapid Quality Reporting System participation. This will go into effect July 1, 2013. All cases must still be submitted to the NCDB in January. To receive commendation, one must participate in RQRS by January 1, 2014.

Surveyor review of cases selected for the CP3R measures will be eliminated for the on-site visit effective immediately. This review may be reinstated by the Accreditation Committee when needed to validate new performance measures.

FORDS has had several changes that are highlighted in Appendix C of the manual. These include a new data item to capture address at diagnosis and birthplace, secondary diagnosis fields to account for the implementation of ICD-10 in 2014, and new override fields for Collaborative Stage. Perhaps the biggest change is that the fields for Ambiguous Terminology at Diagnosis, Date of Conclusive Terminology, Date of Multiple Tumors, Type of Multiple Tumors Reported as One Primary and the Multiplicity Counter have been discontinued for cases diagnosed January 1, 2013 and forward. These are the "New Data Items" in the 2007 MP/H rules. They are still to be collected for cases diagnosed between 2007 and 2012. The morphology grade field is no longer required to be coded for CoC accredited facilities if grade is captured elsewhere in the abstract such as in the Collaborative Stage Site Specific Factors (CS SSF). The "grade/diff" field is coded to "9" if grade is captured elsewhere. FORDS also states that if your Central Registry requires that grade be coded in the histologic grade field, one would continue to code histologic grade. Indiana does require that grade continue to be coded as something other than "9" if applicable even if grade is coded elsewhere. For example, Fuhrman grade 2 renal cell carcinoma would have the Fuhrman grade coded in CS SSF 6 in the kidney schema. Grade 2 is coded in the histologic

"grade/diff" grade field as well as in the CS SSF 6 field for those reporting to the Indiana State Cancer Registry.

In coding recurrence, only code the type of **first** recurrence. A change is that in coding recurrence for lymphoma and leukemia, if a patient relapses, the recurrence code is "59". If a drug such as Gleevec controls either disease process, the patient is considered to be in remission.

SEER RX has recently been updated. Please be sure you are using the most current version. There are several drugs that are no longer coded to chemotherapy. These are: Alemtuzumab/Campath; Bevacizumab/Avastin; Rituximab; Trastuzumab/Herceptin; Pertuzumab/Perjeta; and Cetuximab/Erbitux. Please be sure to always refer to SEER RX when coding systemic treatment.

The Indiana State Cancer Registry purchased the 2012-2013 NACCR Webinar series. I highly encourage all of you to participate, as you are able. The State hosts this event. Each Webinar covers the anatomy of the site being presented, Fords treatment codes as well as Collaborative Stage. They air from 9:00 AM – 12:00 PM and offer 3 CE's for each Webinar. One must register with Marsha Lundy at the State Registry in order to receive the handouts prior to the Webinar. NAACR now requires that one complete a very short quiz to receive the CE certificate. 
