In January each year, ICRA members serving on the Board of Directors are responsible for establishing a set of goals they will strive to accomplish prior to the annual meeting of the membership during the annual Fall Conference.

Included in the 2019 goals listed for the Education Committee was to reestablish communications with surrounding state associations about the possibility of collaborating on a regional workshop. Several members of the association had expressed interest in attending a regional workshop in order to receive commendation for Standard 1.11 in the Commission on Cancer's *Cancer Program Standards: Ensuring Patient-Centered Care* manual.

To date, ICRA has only participated in two regional workshops and both were conducted in 2016. The Indiana Cancer Consortium collaborated with the Kentucky Cancer Registry and the Ohio Cancer Incidence Surveillance System to conduct a regional workshop in 2018.

Many registrars have previously acknowledged they are only allowed to attend one, if any, educational conference per year. Regardless of the organizer, these registrars will understandably opt to attend a national or regional meeting over a local meeting if given the choice. This is apparent when analyzing attendance records for ICRA's Fall Conference. Attendance was lower than expected in the years when regional workshops were offered.

Based on that, ICRA's BOD discussed changing things this year. Consideration was given to scheduling one day of the Fall Conference as an ICRA workshop in order to uphold the bylaws, which state the annual business meeting of ICRA shall be held in conjunction with the annual Fall Conference. The other day of the Fall Conference would be planned with another state and advertised as a regional workshop.

This plan was obviously contingent on another state working with ICRA and agreeing to the already established date and location. Unfortunately, no other state expressed an interest in collaborating with ICRA this year.

The Commission on Cancer will implement new accreditation standards in 2020. A draft version was released earlier this year but it did not include every chapter of the new manual; however, from what was included, commendation ratings may not be included for any standard and the standard pertaining to continuing education for registry staff only requires non-credentialed staff to complete three hours of cancer-related continuing education applicable to their roles. There is no specified requirement for CTR credentialed staff other than the implied requirement necessary to maintain the credential as overseen by the National Cancer Registrars Association.

In light of the proposed new standards, ICRA's BOD has already discussed plans for next year. Although attendance at regional meetings will not be required, nor will it result in a higher compliance rating, the Education Committee will set a goal to collaborate with another state to conduct a regional workshop in 2020.

At this time I am inviting ICRA members to volunteer to serve on the Education Committee in order to accomplish this goal of conducting a regional workshop. If you would be willing to serve as a member of ICRA's Education Committee, please send me an e-mail, lisa.lague@comcast.net.

BY-LAWS committee updates: New proposed BY-LAWS are complete and attached to the Abstract for review. This will be put to a vote at our annual conference this fall. The proposed changes address the language used in BY-LAWS to refer to the fall conference as annual conference.

Quick overview of By-laws committee responsibilities: Ensure that the Board of Directors meetings and Annual business meeting are in line with ICRA By-laws. Robert's Rules of Order, 11th Edition governs ICRA in all cases in which they are applicable and when they are not in conflict with our ICRA By-Laws. Serve as the ad hoc ethics committee as needed. Amendments to the By-laws can be proposed by individual voting members or the Board of Directors.

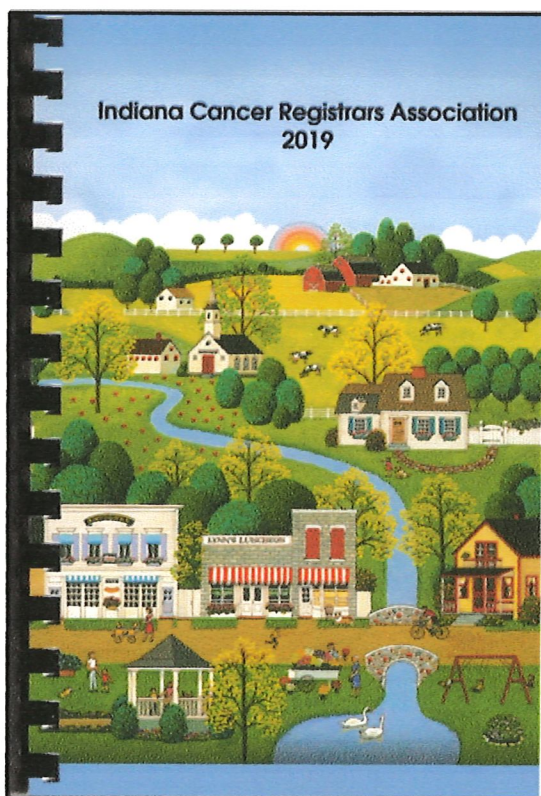

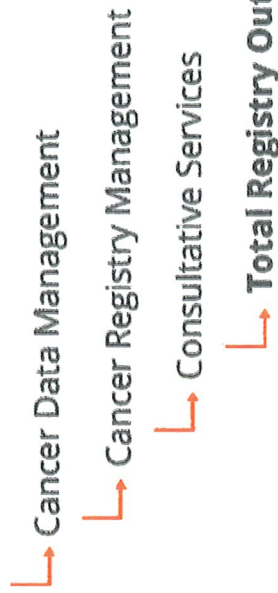

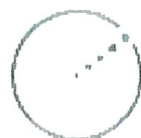
