First, I want to acknowledge the work done by Jan Stengel the last several years as both the ICRA Education Chair and the designated NPCR Education and Training Coordinator for Indiana. As I transition into both roles this year, I can only hope to become as valuable a resource as Jan has been to the registrars in our state.

In cooperation with the Indiana State Cancer Registry (ISCR), three educational workshops are being planned this year. There will be no registration fee for any of these workshops. The first is scheduled for Thursday, March 26 and will cover a variety of topics including cancer registry operations, advanced abstracting and timing rules. Sample cases will be used to demonstrate coding challenges as well. The workshops will be recorded and posted on the Indiana State Department of Health website for viewing at a later date, but attending in person provides a great opportunity to network with other registrars. I encourage everyone to attend if possible. Dates for the next two workshops are not set but projected to be in June and September.

As a reminder, additional opportunities for free educational sessions are offered by ISCR through the NAACCR Webinar Series. The monthly webinars air 9:00 a.m. to 12:00 p.m. EST usually on the first Thursday on the month. Please contact ISCR for more information or to register for these webinars.

Just a reminder, the Indiana State Cancer Registry (ISCR) has purchased the 2015-2016 North American Association of Central Cancer Registries (NAACCR) webinar series. This series is available at no cost to individual CTRs. Please contact Marsha Lundy if you would like more information: (317)233-7158.

The ISCR submitted 2012 data to both NAACCR and the Centers for Disease Control and Prevention's (CDC) National Program of Cancer Registries in November, 2014. Results of the quality, timeliness, and completeness are pending. Both of these submissions directly reflect of the outstanding work of CTRs across Indiana. If the data are acceptable Indiana will be included in the Cancer Incidence in North America and the United States Cancer Statistics publications.

Utilizing cancer data collected from reporting entities in Indiana, Cancer Surveillance Section Director, Laura Ruppert, MHA, Cancer Epidemiologist, Amanda Raftery, MPH, RD, and Behavioral Risk Factor Surveillance System Coordinator, Linda Stemnock presented the cancer burden at the first ICC District 10 Coalition meeting on February 18, 2015.
