I first wanted to share an update from my February webinar where I introduced the update surrounding the use of Bi, Pi and Li-Rads imaging for diagnosis date, per STORE 2023 update. As of March 3, NCDB started posting on the CAnswer Forum that we are NO LONGER to use and -Rads imaging dates for a date of diagnosis, even when later proven malignant by biopsy. They have now posted a new version of STORE 2023, so make sure you download that manual. You may have to delete old versions you have bookmarked and clear cookies to make sure you have the one noted to be released on 2/28/2023.

Looking at the year ahead, I plan to provide two more educational webinars – free to ICRA members. I am tossing around the idea of doing one geared towards CoC and NAPBC accreditations; I know not all of you work for an accredited facility, but many do and it may be beneficial?
